Notice of Race

1. Rules

- 1.1 The race will be governed by the rules as defined in the current Racing Rules of Sailing, as modified by the sailing instructions.
- 1.2 Press Passengers are permitted. See NOR #2.4

2. Eligibility & Entry

- 2.1 To be eligible boats shall be sailed a crew of two individuals (including the skipper).
- 2.2 The regatta is open to all boats of the JAM and PHRF Classes. A One Design Class will be provided, if 5 or more boats of a Class register. PHRF multi-sail ratings will be used to make fleet splits.
- 2.3 Eligible boats may enter by completing the online registration form, (See NOR #4.1) or completing the attached entry form and sending it to Dale Benedict (See below for contact information).
- 2.4 Non-participating guests are permitted. If a skipper wishes to have guests on board during a race a sign must be affixed to each side of the boat bearing the word "PRESS". Guests may not give advice may and may not aid the racers in any way except by serving refreshments. They may not be instructed in where to sit or what to do except to keep them out of harm's way.

3. Fees

Entry Fee: \$20 US dollars [Non-US Sailing members: Add \$3.00] by **May 9th, 2018**, to ensure proper fleet splits.

May 12, 2018 Approximately 2 hrs after the last boat to finish, at CSYC Clubhouse including a casual get-together with hot dogs, hamburgers and beverages supplied by the CSYC. Bring your friends; everyone is welcome to attend. Results will be posted on www.crescentsail.com within a few days.

5. Measurement

Each boat shall produce valid rating information when registering.

6. Sailing Instructions

Sailing Instructions will be available on the on the "Hind/Hornett Regattas" page of at www.crescentsail.com

7. Venue

The start and finish will be from Crescent Sail Yacht Club, 276 Lake Shore Drive, Grosse Pointe Farms, MI. The course shall be approximately 13.7 miles in the SW corner of Lake St. Claire. The shortened course will be approximately 11.5 miles.

8. Scoring

- 8.1 PHRF scoring shall be used.
- 8.2 One race shall be required to constitute the series

9. Prizes

Flags for the first three finishers in each class shall be awarded.

10. Documentation Compliance

Entrants are reminded to be in compliance with all necessary documentation required (i.e. passports, Nexus, etc.) for the United States and Canadian borders, for the skipper, crew, “press passengers,” boat, etc., as applicable.

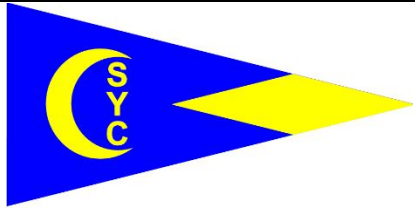
