YOU AND YOUR CREW AGREE TO INDEMNIFY AND HOLD HARMLESS THE GROSSE POINTE FARMS BOAT, ITS MEMBERS AND OFFICERS AND AFFILIATED PARTIES FROM ANY LOSS OR DAMAGE TO PERSONS OR PROPERTY ON YOUR VESSEL (INCLUDING, BUT LIMITED TO SERIOUS INJURY OR DEATH) RESULTING IN ANY WAY FROM YOUR PARTICIPATION IN ANY OF THESE RACES OR RELATED EVENTS.
